

## Register of Allocation Participants

The Gas (Downstream Reconciliation) Rules 2008 (the Rules) require the exchange of information between the allocation agent and allocation participants. Allocation participants also receive notices from Gas Industry Co and must be consulted on defined issues as required by the Rules. Allocation participants are defined by rule 2 of the Rules to comprise retailers, distributors, meter owners, or transmission system owners.

The register set out below lists those allocation participants who have advised their status as an allocation participant to Gas Industry Co. The list may not be complete, or details may be out of date, as it relies on companies notifying Gas Industry Co of their status under the Rules.
